## ADDENDUM NO. 3 TO BIDDING DOCUMENT ISSUED ON 22<sup>ND</sup> OCTOBER 2024

The Amendments constituting Addendum No. 3 to the Bidding Document indicated below, shall be effective and form part of the Bidding Document on the date of issue of the Addendum and any part (s) of the original Bidding Document not amended shall remain unchanged.

The Amendments are as follows.

### AMENDMENT 1 : SECTION IV: SUBMISSION FORMS

- 4. Bill of Quantities (BOQs) (page 99)
  - (1) MCA-Malawi amended the Bill of Quantities (BOQs) to include the following:
    - As per the scope of work, the box culvert at chainage 0+000 is missing from the Bill of Quantities (BoQ).
    - Discrepancies observed in chainages between the work description and the BoQ (e.g., chainage 1+167 in the work description is listed as 1+161 in the BoQ, and chainage 22+320 in the work description is listed as 22+324 in the BoQ).
    - Bill 1600 Overhaul" is to be carried to main summary.
    - Bill item 6103, (b) Drainage. The item is missing and be introduced in the bill
    - Bill Item 6202 (ii) Pier Stem. Item to be **deleted** since all bridges in both corridors are single span which have no Piers

### AMENDMENT 3: TO THE FINAL TECH SPECS PART B - PARTICULAR SPECIFICATIONS

The following changes have been made as indicated to the respective Particular Specifications for both CL and CM corridors.

The type of DPGS and Total Stations has been specified under PS 1205 as follows:

All reference to concrete blocks or concrete columns and beams has been modified in 1402 and 1403 as follows:

#### **PS 1402 Offices and Laboratories**

Buildings for offices and laboratory shall be of modular construction, or other approved materials.

#### PS 1403 Housing

#### (a) Staff houses

Staff houses shall be constructed from modular or other approved material.

The main frame of each house shall be of modular columns and beams.

#### The pay item has been modified as below:

#### **PS 14.06 Engineer's Housing Accommodation**

Construct housing for the Engineer's staff as specified:

(c) Type IV Junior Level Housing including furniture and equipment ......Number

#### PS 5707 has been modified to include the following:

#### PS 5707 Provision of Plants and shrubs and Planting Management Requirements

All tree or shrub plant material is to be selected based on site conditions and constraints and shall be obtained from the local Forestry Office which is the District Forestry Office through which the corridor passes and they shall advise on which type of trees and shrubs to be planted within a particular locality.

Except as expressly amended by this Addendum, all other terms and conditions of the Bidding Document issued on 18<sup>th</sup> September 2024, remain unchanged and shall remain in full force and effect in accordance with their terms.
