The United States of America and the Government of the Republic of Malawi (the "Government") signed on September 28, 2022, a Millennium Challenge Compact ("Compact") for an amount of US\$ 350 Million, for a program to advance economic growth and reduce poverty in Malawi. The Government, acting through the Millennium Challenge Account-Malawi II (MCA-Malawi II), intends to apply a portion of the proceeds to eligible payments for the construction of in-kind compensation houses and commercial stand-alone structures to be built in Mangochi, Ntcheu, Lilongwe, Mchinji, Kasungu, Mzimba and Rumphi districts along the Corridor Roads of Accelerated Growth Corridors ("AGC") Project of the Compact.

Any payments made under the proposed contracts will be subject, in all respects, to the terms and conditions of the Compact and related documents, including restrictions on the use and distribution of MCC Funding. The Compact and its related documents can be found at the MCC website (www.mcc.gov).

The Government has designated the MCA-Malawi II, to implement Government's responsibilities under the Compact.

MCC's funding is appropriated by the U.S. Congress and obligated to the Compact up-front, with no incremental or partial funding. So when a contract is signed with MCA-Malawi II, money is already available to MCA-Malawi II and all invoices are paid directly to Offerors by the US Treasury.

MCA- Malawi II now invites **password protected Offers** from eligible Offerors and intends to award up to six (6) IDIQ Contracts each for a period of twenty-four (24) months.

Bidding will be conducted through the procurement method of Competitive Bidding (CB) as per the procedures as specified in the Accountable Entity Procurement Policy and Guidelines (AE PPG), and is open to all eligible offerors as defined in the PPG, that are provided on the MCC website (www.mcc.gov).

An IDIQ Contract Holder will be assured of at least one (1) Work-Order (WO) award under the IDIQ Contract. Thereafter, WO will be awarded on a competitive basis. Details of the WOs competitive process can be found in Section III - Qualification and Evaluation Criteria of the Bidding Document.

Work Order Award shall comprise the Construction of In-Kind Compensation Houses and Commercial Stand Alone Structures to be built in Mangochi, Ntcheu, Lilongwe, Mchinji, Kasungu, Mzimba and Rumphi districts; in the varying mix of the following Types of Structure:

Single Storey Dwelling Houses (1 to 4 Bedrooms), Outdoor Kitchen, Outdoor Ablution Block and Single Storey Commercial Buildings (Shops: Option 1 and 2).

More details of the required works can be found in Section V- Employer's Requirements of the Bidding Document; which include the Drawings, Specifications and Bill of Quantities.
